V Universal City Studios, which ruled that Sony as producers of the Betamax, a technology capable of illegal copying of material, were protected from copyright infringement of its users because the technology was "capable of substantial noninfringing uses.. The act of promoting infringement was known as "inducement" in the court Gorton did not believe that as long as he did not "induce" user infringement that he would be in the clear..
